### **Get ready for NMA's Annual Speech Contest**

An early marquee event on the 2017 NMA calendar occurs next month, with the NMA Speech Contest, Thursday, February 23, from 4:30 – 8:00 pm, at the Southfield BCN Commons. The 2017 Executive Keynote Speaker is the ever-dynamic Orin Lewis, director, Auto & Web Support Help Desk.

Twelve local high school students will compete for the chance to advance through local and regional competition to attend the national competition, as finalists during the 2017 annual NMA convention. Students there will compete for a \$4,000 grand prize college scholarship.

Last year Chapter #141 experienced the collective and exhilarating thrill of watching our contest winner, Soumya Kulkarni, advance through local and regional competitions, to become one of four national finalists to compete last September at the NMA convention in New Orleans. Kulkarni, a student at Northville High School, placed second with her speech titled, "Finding the Leader in You." When asked about her contest experience, Kulkarni, who hopes to study medicine after graduating from high school in 2018 said, "The 2016 NMA Speech Competition was absolutely one of the most amazing experiences in my life. ... I met some of the strongest and fiercest women I have ever met through NMA and Toastmasters. ... women (who) mentored me and gave me fabulous advice...It was an incredibly rewarding and humbling experience -- I'm so thankful to NMA for giving me this wonderful opportunity and I can't wait to hopefully do it again!"

VP Human Performance Laura Byars, the 2016 Executive Keynote Speaker, recounts with passion her involvement in last year's event.

Asked about the importance of the speech contest and its significance to NMA, Byars discussed it in the context of leading by teaching. Leadership insists on being able to stand in front of an audience and effectively articulate an idea. The NMA speech contest offers a teachable, safe *and* challenging platform for students to present their ideas on leadership within the atmosphere of a competitive event. When asked what kind of challenge she experienced as an executive associated with the contest, Byars laughs and shares that it was in presenting *her* keynote speech. Pressed to explain, since she's obviously made innumerable executive level speeches in her career, Byars said that it was the anticipation of speaking in front of the supporters of the student contestants. Parents, friends, family, teachers and others in the audience were sitting there in anxious anticipation of experiencing the success of their young loved one, and *that* made her feel nervous for them.

#### Fired up & ready to go: Orin Lewis on Transformational Leadership

On Thursday February 23, 2017, Orin Lewis, director, Auto & Web Help Desk Services was introduced by Dan D'Amico, Sales Manager Labor Relations, to a large and enthusiastic audience at BCN Commons. Orin launched the 2017 NMA Speech contest, in the spirit of the contest's theme, by delivering a PowerPoint slide presentation entitled, Transformational Leadership.

Orin delivered his presentation for the listening benefit of both the young contestants sitting in the audience and for the adults listening in rapt attention to his discussion on the style of leadership required in the new millennia.

As Orin progressed through his presentation, he weighed his speech with examples of transformation in action.

"Life is not given, it's taken." Transformational Leadership is briefly defined as change in individuals and systems that create value and positive change. It manifests by developing people into leaders. A transformational leader deftly manages strengths and, without overlooking weaknesses, sources it as an opportunity for corporate and personal growth. Transformational leaders selflessly equip others with the required tools to foster positive change.

Orin reviewed mega-trends in the workforce as contributing factors in the evolution of Transformational Leadership: rapid urbanization, climate change, shifts in the global economy, changing demographics, and light-speed advances in technology. By way of illustration, Orin described an eye-opening experiment conducted with elementary school third-graders. These future "masterminds," were able at their tender ages, to draw distinctions between leaders and bosses, befitting a graduate school MBA. Cultivation is a key component in the tool kit of a transformational leader.

Orin went on to give a detailed description of the Transformational Leadership Model, and closed his speech with an illustrated video of a Barack Obama speech on the power of one voice. A woman entered a room where Obama was just concluding a not so successful campaign speech on his first run for the presidency and exclaimed, "Fired Up?" To Obama's complete surprise the entire room returned this lady's words with their own, "Fired Up!" This same woman then replied, "Ready to Go?" And again, the entire room responded, "Ready to Go!" And with that, Obama said he received a sense of restoration, and left the meeting Fired Up and Ready to Go in pursuit of his own vision.

With that type of ending, how do you suppose Orin ended his speech, launching these children, and his audience in pursuit of their own dreams? You got it: Fired Up and Ready to Go!

### NMA's Annual Speech Contest 2017

#### And the winner is. . .



- I know it's politically correct to say, "and the award goes to...", but truly there were many winners at the NMA speech contest last Thursday: contestants, mentors, parents, and all audience members.
- The contestants were introduced somewhat anonymously; no school affiliations or backgrounds were announced beforehand, and letters A to I identified each of the nine finalists. We all watched as each student walked from the back of the auditorium to the front of the room, and their poise, dignity and confidence was evident as they individually addressed a diverse crowd of almost 100 people.
- Contestant A's assertion that women are the future certainly caught my attention. Contestant B is a strong proponent of gender equality and posited that leadership is an accumulation of small actions. Contestant C shared a story about three stonecutters who were each asked what they were doing. The first answered he was cutting stone; the second that he was making sure the stones he cut would fit together and be strong. The third stonecutter responded, "I am building a cathedral."
- Contestant D focused on three renowned abolitionists who may not have realized the impact they would have as they morphed into leaders fighting for the end to slavery. Contestant E likened leadership to an onion layers are peeled away as the core of ideas and impact is revealed. "What is an MVP?" contestant F asked. The qualities of a leader: Motivation, Vision, Persistence.
- Contestant G described three forms of leadership gleaned from a Google search but shared his father's response: direct and indirect. Contestant H gave us her personal story of life so far and how she was able to become a leader following a non-traditional road. Contestant I summed up the most important qualities of a leader: confidence, a willingness to learn, and a desire to help others.







He then jumped right into his speech, talking about business and leadership. He explained that the best companies have a growth mindset and that crafting a mission statement must align to today's world. Blue Cross Blue Shield Michigan's 2017 mission statement says, "We commit to being our members' trusted partner by providing affordable, innovative products that improve their care and health."

John asked his audience many good questions, such as "Why do people choose BCBS[M and BCN]?" "Who is BCBSM in this era?" and "Can there be one Blue Cross story?"

Thursday March 31, 2017: It was a rainy day in downtown Detroit, but the weather didn't keep us out. Brian Wilkes, our 2017 Chapter President, introduced John Fikany, Vice President of Strategy & Business Development at Quicken Loans. After many of his professional accomplishments and accolades were announced John stated, "I'm a family man, period." His presentation was personal and thought-provoking. There was a video of his 6 year old daughter, wise beyond her years, telling her father he should, "Do something special for someone special." The golden rule still applies: treat others how you want to be treated.

John mentioned that for this to happen, the company must promote clarity and alignment, an obsession with its customers, embracement of change, and valuing its people. He told us that it's bad cultures that kill good companies and that diversity is just as important as the aforementioned. He encouraged us to keep an open mind, as this is a great definition of diversity. As we are already aware, Blue Cross does extensive training with us on our company's culture, mission, vision, values and beliefs.

On leadership, John brought up the challenges we face in the new normal, such as high expectations on all, and having to do more with less. John lightened things up by playing and singing along to the song, "Under Pressure." John sprinkled his sense of humor throughout his presentation. He let us know that these challenges can create unintentional consequences, such as the disappearance of inspirational leaders. He said once there is less transparency, lack of accountability, lack of trust and less empowerment, fears creep in and oppression (the absolute worst) can occur. We cannot let this happen to us! He went on to say that trust *is* leadership and challenged us to keep improving. He stated that he wants us to think, "Man, I've got to go hug one of my people." We cannot be afraid to give our employees some freedom, because this brings empowerment and says, "I trust you."

He also touched on employee engagement, referencing the latest Gallup poll which found that only 15% of employees are "actively engaged" in work, which means they bring it all, and 5% are actively disengaged. Good solid communication is needed to improve engagement. He stressed the importance of recognizing the value of your people. Quicken Loans has a ceremony called "The Gilbert Awards" that recognizes and awards employees. And get this, it lasts four days! He made a point that people don't leave overnight and that as a leader you have to ask yourself, "Where are my people at right now?" Another question and challenge is how do we keep them engaged? He discussed the importance of keeping our focus and not taking our eye off the ball.



# NMA's Lunch and Learn: "Time Management"

Have you cleaned out your inbox lately? On Thursday, May 18, we learned why you should . Valentine Smith, CM, explained the value of "Time Management" during a NMA Professional Development Lunch and Learn session. In his nationwide webinar presentation, Valentine gave his audience logical approaches to managing time and increasing productivity, based on his degree in Organizational Leadership and experience as Airport Duty Manager at the busy Port of Seattle, Seattle-Tacoma International Airport. During the well-attended local gathering hosted by NMA's own Sharese Hogan (Tower location), heads could be seen nodding in agreement as Valentine proceeded through his well-organized and well thought out presentation. NMA members also gathered at the RenCen and at The Commons in Southfield.

Goals should be S-M-A-R-T: Specific; Measurable; Achievable; Realistic; Tasks.

**Beware of shiny objects**. While planning your day is not difficult, exercising discipline in execution is. Commit to stay on task. Valentine humorously described notifications, pop-ups, and IM's as shiny attention grabbing distractions that have the potential to whittle away your productivity. Then, you tolerate your time being managed by someone other than yourself.

**Use lists**. Lists help create a natural flow, allowing you to prioritize daily, weekly, monthly, and annual goals. The ability to check items off your list is a great feeling, providing a natural reward for mission accomplished. Prioritizing is easy as: 1-Today no matter what; 2-Today, if possible; and 3-Today, if time is left over. Use multiple calendars, one for personal, for work, for family, and for academic. Remember to reschedule incomplete items.

Valentine used the college experience as a method of demonstrating the difference between a goal and its tasks. The goal or objective is the big picture - graduate and obtain a degree. The tasks are, go to class, do the homework, and pass the exams. Even though each task is made up of component pieces, it was an effective example in helping us begin to visualize ways of measuring and managing our finite allotment of time.

Valentine pointed out more ways of using our time wisely: managing distractions, keeping our inbox clean, practicing efficient use of the phone, avoiding inefficient meetings, and avoiding idle chatter. One major take away from his presentation was to keep your boss focused by managing up; engage their help in removing obstacles.

Commit to change by being honest. Eliminate wasted time and effort. If you're known for being efficient, it might mean that you're just good at being busy. It's better to be counted on as being effective and known for managing what's really important. Avoid work that doesn't move you forward. It's your time; you won't get any more of it.






#### Maximizing Your Membership




#### Massage Therapy







#### NMA Professional Development: Improving communications in a busy world

Bombarded by self-replicating, redundant emails? Locked in e-mail jail? On Thursday, August 17, Renee Brooks, Senior Communications Specialist at Mission Support Alliance, led a lively webinar presentation on improving communication in our increasingly busy, data saturated workplaces. The webinar was viewed at various locations around Blue Cross and BCN by NMA members seen taking serious notes during her hour-long, information packed presentation.

Opening with the George Bernard Shaw quote that, "The single biggest problem in communication is the illusion that it has taken place," Renee explained how the illusion of being an effective communicator breaks down when it's been determined that the intended message is not received, or not properly processed by the intended receiver.

Communication is such a wide ranging, highly complex subject that fundamental to its understanding is an appreciation for the two elements integral to its evolution: methods and audience. From playful tin cans on a string to satellites in space, communication technology morphs daily. Yesterday's phone booth is today's Bluetooth enabled car. And today, a multi-generational workforce sits together in a corporate presentation to process information via highly individualized methods. Renee has these highlights for communicating effectively in today's information drenched world.

- ➤ **Listen**. It's the foundation of effective communication. Learn to listen and then practice listening. Listening to understand requires eliminating distractions. Listening with the goal of simply responding is a fast way to create misunderstanding.
- ➤ **Be organized**. What's the intended purpose of your communication effort? Renee presented a slide of a communication impact grid, showing levels of purpose, ranging from low-level entertainment purpose to highest level taking action purpose, the most difficult to achieve.
- ➤ **Plan.** Make a commitment to prepare a formal communication plan, even for the most basic communication piece: who, what, where, when and how.

To clear clutter from internal corporate communication, Renee suggested the following tips:

- 1. Since people don't read everything you write, get to the point. Be concise and edit for impact.
- 2. Cut "weasel words," like *really, so, and then*; they don't advance your message.
- 3. Reduce redundancies: ATM machine, hot-water heater.
- 4. If possible, avoid the word "but" in a sentence; it's usually ignored.
- 5. Use a simple greeting when sending an email; personalizing your message makes it effective.
- 6. "Keep it simple, silly" (KISS). Know your audience when composing correspondence.



October Member Meeting: "The Power of Inclusive Leadership"

In an atmosphere of sophistication and cultural immersion, Bridget Hurd, senior director, Diversity and Inclusion hosted the October NMA monthly membership meeting at the Charles H. Wright Museum of African American History. The museum bills itself, with the exception of the new national museum in D.C, as the largest museum in the country dedicated to the African-American experience. One of the oldest museums of its kind, "The Wright" was the perfect platform for Ms. Hurd to discuss the significance of diversity and inclusion at Blue Cross and its implications on society at large.

Hurd greeted the group by acknowledging how Diversity and Inclusion's objectives dovetailing to capture President Tina Alonzo's NMA theme and vision for the year, "Diversifying the Image of Leadership." She then launched her presentation with an overview of her twenty-four year PR and Communications career, the last seven with Blue Cross. Hurd emphasized how necessary it is that anyone pursuing career advancement have a personal brand that crystallizes their career identity. Hurd's brand is "change agent." She described how passion for her brand pushes her beyond her "ambivert" (being somewhere between an extrovert and an introvert) tendencies to take on silos hindering Blue Cross from becoming a more diverse and inclusive company.

Hurd continued through her evening's talk by dispelling the presumption that diversity is synonymous with inclusion. Diversity and inclusion are separate conscientious steps that organizations must make if they are interested in receiving the full benefits of a workforce so identified.

Hurd went through the slide presentation that gave a visual representation of the difference between separation, integration and inclusion. Using cells drawn to resemble culture stains under a microscope lens, one view showed two unconnected cells, one multi-colored the other not. The next view showed multi-colored cells clustered together inside one large cell. The final view displayed multi-colored cells fully dispersed throughout the larger cell. "Inclusion is the sense of belonging. Molecules have to bump around and bounce off each other," Hurd said. Diversity is not inclusion.



Progressing through her presentation, Hurd incorporated feedback received in response to various questions regarding diversity in the audience. "How many speak more than one language?" "Who's lived in the most states?" "Who comes from a large family?" Her questions were designed to raise awareness of the diversity within the community of NMA and to become sensitive to individual latent biases. "We have to be 'woke' in order to expand our consciousness," Hurd said in conclusion. She simply, humbly and effectively made the point that diversity is ineffective without inclusion.

Becoming Financially Sound:
"Lunch and Learn" with Joseph Samples III

On Friday the thirteenth, at the October lunch and learn hosted by NMA's Professional Development team, Joseph Samples III of Samples and Young financial services, Southfield, Michigan, discussed the emotional subject of money with authority, compassion and humor. "Let's talk about the 'B' word," he said smiling. And, after a long pause for effect he finished with "Budget."

"Wisdom is best gained by experience," Samples said launching a seamless forty-five minute information loaded presentation. In front of the largest Professional Development audience of the year, Samples shared wisdom gained from twenty-plus years in the financial services industry citing examples from a client list exceeding five-hundred.

Throughout his presentation Samples emphasized principles captured by the time value of money. "The more time you have to invest, the less money you'll have to save. The less time you have to invest, the more you'll have to save," he said. Simple principle, but making it work takes the beauty and discipline of the ugly "B" word.

Illustrating the allure of his point, Samples clicked to a chart detailing an effective, nearly painless method of socking away nearly \$3000 a year by simply making small daily deposits. The method is to save, in dollars, the amount represented by the date of the month on the calendar through the  $16^{th}$  day of the month; on the  $7^{th}$  deposit \$7.00, on the  $10^{th}$  deposit \$10, and so on. On the  $17^{th}$  day of the month restart the cycle at \$1.00 and make ascending daily deposits until the  $1^{st}$  of the month and then start all over again. The use of a calendar to achieve savings goals functions as a literal reinforcement of the time value of money.

Samples received nods of agreement when asked if the audience had heard of "Boomers," "Gen X'ers" or "Millennials." He then described the lesser known group known as the "Sandwich Generation," a group sandwiched between career and caregiver, having either adult children living at home or responsible for attending to elderly parents. "This group's time and money are being pulled in both directions," Samples said, "with little leftover for planning a future."

Time with Samples escaped as quickly as dollars spent on daily double espressos. He wrapped up his message by nailing down estate planning as the symbolic roof of a structured, well managed and goal focused financial plan. (Continued on next page.)

In the wake of the largest identity breach in history, Samples touched briefly on the subject of identity theft and suggested that the audience seek a credit monitoring company that insures against loss and provides restoration services. Zander was a company he'd worked with in the past, but check with the Better Business Bureau for names of other reputable companies. Finally, before taking audience questions, he recommended that everyone should get a free copy of the booklet *Identity Theft, A Recovery Plan*, created by the U.S. government.

The time spent with Samples encouraged everyone in attendance to utilize the critical information he'd

provided in less than an hour, to begin taking the first small tentative steps that lead to securing a safe and sound financial house.

# Mark Brown: Understanding Multi-generational Workforces

Several break-out groups discuss key "identifiers" of each generational group: Traditionalists, Baby Boomers, Generation X, Xennials, Millenials and Post-Millennials.

In most thriving organizations today, you will encounter a culturally diverse workforce of different nationalities, various religions, genders and ages. Mark Brown, HR Organizational Consultant lead a lively interactive discussion with BCBSM's Young Professional Network and NMA. His presentation focused on the importance of understanding the mind-set of each generational group, their belief systems and what they value most.

Mark's activity-driven session allowed different break-out groups to interact with one another. Each group discussed what Their assigned generation experienced and how these encounters fostered their family life, financial decisions and work ethics.

Together, with helpful insight from Mark, we delved into topics such as the Market Crash and the Great Depression, the turbulent sixties, the technology boom of the late nineties and current technological advances. We discovered that much of what we thought about each generation and the stereotypes we assigned were wrong; that's the beauty of engaging each other in open dialogue.

Laced throughout Mark's presentation was the important factor of working together in spite of age differences. In order for this juncture to work, we must know the benefits of working within a multi-generational team. Some key points are:

- Team flexibility
- Stronger decisions within the group because they are broad-based
- Innovation and creativity
- Goals are achieved because of the diverse work environment

By the end of this discussion, all participants had one key takeaway: in order to survive the changes of an organization, you must be flexible and willing to adapt to other styles. Be open to actively listening to each other and put away pre-judgments about what the older or younger generation is willing or not willing to do. If we can do this wholeheartedly, then we can be effective leaders in so many ways.

# November Member Meeting: "The Strategy of Grategy"

Keynote speaker Lisa Ryan opened the night's events with a startling quote from Mother Teresa, "People are more starved for attention than for bread." This actor, author and motivational speaker then worked the audience into a frenzy of gratefulness the evening of Wednesday Nov. 15 in a pre-Thanksgiving night of gratitude, Blue Cross style.

Ryan drove in from Cleveland on a dark rainy evening to shine a light on the effectiveness of employee appreciation and how it operates as a vehicle to propel the fully engaged employee. Ryan is the founder and owner of *Grategy* a company and a word that she created to describe the strategy of gratitude. Her focus in speaking to companies across the country is to help them attract and retain the best and brightest workforce.

Ryan walked among the seated guests and ticked off a list of fast facts, without notes, that highlighted the adverse consequences of an unengaged employee. Citing Gallup poll statistics, she noted when 30% of an employee workforce is engaged, they bring more value to the company than they're paid. Another 50% is moderately engaged, collecting enough of a check to stay but not enough to quit. And, the remaining 20% is an actively disengaged check collector that, unsurprisingly, actively recruits from the 50%. A Google search of Ryan's business provides additional evidence:

- When a customer stops doing business with a company, 68% of the time it's because they feel ignored, underappreciated, or taken for granted.
- Only 42% of employees say that they've received any kind of recognition in the past year.

Ryan was asked by our president, Tina Alonzo, "How do you recommend connecting with an unconnected employee?" Ryan then dropped a poetic pearl saying, "Remember Steady Eddie, what gets recognized gets repeated." As managers, Ryan cautioned that we demand a culture of safety and consistently look for the positive in people, even if it takes a microscope. And, she said, remember that your leaders need sincere recognition too, not "yes" men.

Before ending the night with a raffle to win copies of her books, Ryan had the audience perform a simple exercise that at first blush seemed meaningless, but once performed, became powerful. Each seated guest exchanged, "Thank you", "You're Welcome," with their neighbors three times in succession before switching roles, then once completed turn to the other neighbor and repeat the cycle.

Among uncomfortable smiles and nervous laughter, the participants began to experience a reduction in the stress of being grateful. Ryan used this exercise to demonstrate the fact that we're hardwired for negativity. When someone compliments you, the only acceptable response is, "Thank you." Ryan explained that we are taking away the gift the speaker is attempting to give when we qualify their observation with our own assessment. Willingly receive the compliment, it indulges the giver and refreshes the receiver.

Before leaving Ryan drew our attention to blank thank you card liberally dispersed on all the tables and encouraged everyone to take a few and use them. What better way to end the night than by picking up our thanks and passing them on to others as an application and a reminder of the lessons learned that night.

An Evening with Marlin Williams at TechTown

Our last membership meeting of the calendar year was held at <u>Tech Town</u>, located in the up and coming Midtown Detroit. The space was open and bustling with activity. They had bike racks, recycling bins, vibrant colors and charge ports galore. Our designated meeting space was decorated with Navy Blue and Silver, reflective of the holiday decorations during this time of the year.

Tina Alonzo, our NMA chapter President was there to greet members, along with other NMA volunteers. It is always nice to be greeted with warm smiles. Our guest, Marlin Williams reflected that same warmth.

Marlin spoke to us about: "Personal, Passionate, Purposeful Leadership." She is a Detroit native raised by hard working parents who were preachers. Her college journey took her to Florida A & M University in Tallahassee, then back to Michigan to study at Wayne State University. After college, she began working as a mortician at Swanson Funeral Home. At one point, she even pursued a singing career, but that didn't work out either. Marlin wasn't aware of her purpose or passion.
