Santis, an epoch in the history of the Harbor-UCLA Medical Center NMA chapter has come to an end. Frank passed away on April 25 after a long illness.

Remembering Frank De Santis

Frank J. De Santis joined the Harbor-UCLA Medical Center in 1959 (then known as Harbor General Hospital) as a professional personnel director. In 1963, Frank became the first Research Administrator for the Frank supported the Harbor Attending Staff Association, the first Chief Executive Officer and first President of the Research and Education Insti-Los Angeles Biomedical Re-The Lundquist Institute. In those positions, Frank raised millions of dollars in research funding and new, modern research laboratories and building facilities for over 600 research and education projects and contracts. Frank retired from LA Biomed in 1997.

In 1966, Frank and Edward J. Foley, the new Personnel Director of the Harbor-UCLA Medical Center at that time, were successful in establishing a management chapter at Harbor, affiliated with the National Management Association (NMA). NMA had an excellent over 50 years. track record with many aero-

space companies. Because of the rapid growth that was taking place in hospital services involving employees and the medical staff, the chapter membership was extended to all of the employees based at Harbor-UCLA Medical Center. The Harbor NMA chapter was the first health organization chapter in NMA. Over the next few years, other chapters were also established, because of the success of the Harbor chapter.



Gold and Silver Knights

NEEDS APPROVAL

The Gold Knight (Councils) and the Silver Knight (Chapters) are the highest awards that can be bestowed upon an outstanding executive. Only one may be presented in a year by any council or chapter. The nominee must be an executive whose reputation for outstanding leadership is well-known in the area served by the Chapter/Council. The nominee must be a person who has demonstrated the highest qualities of leadership in business or government as well as being involved in community activities.
